- Conduct of joint workshops, symposia, etc. on topics of mutual interest.

Financial Arrangements

It is also understood that any financial arrangements will be negotiated in each specific case and will depend upon the availability of funds. 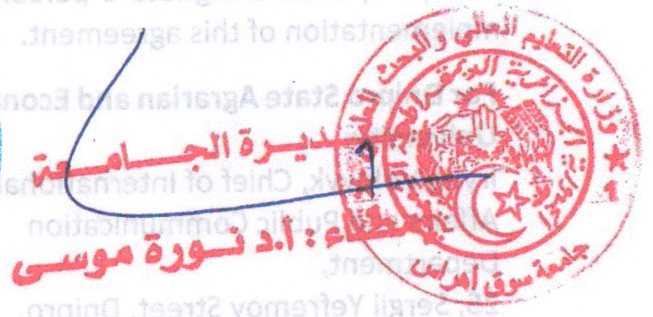
